By accessing, browsing, using this Website, submitting information, or making any payment, the user (“User,” “Mare Owner,” or “you”) acknowledges and agrees to be legally bound by these Terms and Conditions of Use and Privacy Policy (collectively, the “Website Terms”).

1. ACCEPTANCE & LEGAL EFFECT

These Website Terms constitute a binding legal agreement under the laws of the State of Georgia.

By using this Website, you expressly agree that:

- You have the legal capacity to enter contracts;

2. RELATIONSHIP TO BREEDING SERVICES AGREEMENT

This Website does not replace, modify, amend, or supersede the Breeding Services Agreement – 4 Stallions Ranch LLC (the “Breeding Agreement”).

- No breeding rights arise from Website use;
- No contractual relationship exists until written acceptance by 4SR of a fully executed Breeding Agreement;
- In case of conflict, the Breeding Agreement controls.

3. PURPOSE & PERMITTED USE OF THE WEBSITE

This Website is intended solely to:

- Provide general information about 4SR programs and stallions;
- Facilitate administrative intake;
- Allow payment of the Booking Fee;
- Communicate pre-contractual information.

You may not use this Website to:

- Misrepresent identity or ownership of a mare;
- Attempt unauthorized semen access;
- Interfere with Website functionality;
- Circumvent contractual restrictions.

Unauthorized or abusive use may result in access termination and legal action.

4. NO GUARANTEE OF SERVICES OR OUTCOMES

4SR expressly disclaims any guarantee or warranty, including but not limited to:

- Acceptance into any breeding program;
- Semen availability on specific dates;

All breeding services are biological and inherently uncertain, as acknowledged in the Breeding Agreement.

5. BOOKING FEE – FULL LEGAL DISCLOSURE

5.1 Nature of the Booking Fee

The Booking Fee:

- Is an administrative, non-refundable fee;
- Reserves only the review and administrative processing of a potential Breeding Agreement;
- Is not a sale, license, or breeding right;
- Creates no obligation on 4SR to provide services.

5.2 Mandatory & Non-Refundable

Payment of the Booking Fee is required to initiate the process and is strictly NON-REFUNDABLE, including but not limited to situations involving:

- Failure to complete documentation;
- Mare ineligibility;
- Veterinary rejection;
- Administrative or legal rejection by 4SR;
- Voluntary withdrawal by the User.

6. CONTRACT REVIEW & USER RESPONSIBILITY

The User acknowledges:

- Full responsibility to review the Breeding Agreement prior to payment;
- Responsibility to understand all fees, reporting duties, veterinary requirements, and non-refundability of payments;
- That ignorance of terms is not a defense.

7. ELIGIBILITY & APPROVAL

All services are subject to:

- Full compliance with contractual requirements;
- Veterinary approval;
- Timely and accurate documentation;
- Availability and program capacity.

4SR reserves the sole and absolute discretion to accept, reject, postpone, or cancel any request without obligation to refund.

8. ELECTRONIC PAYMENTS & E-COMMERCE TERMS

Payments made through this Website:

- Are processed via authorized third-party processors;
- Are subject to processing and convenience fees;
- Are governed by U.S. and Georgia commercial law.

We do not sell personal data.
